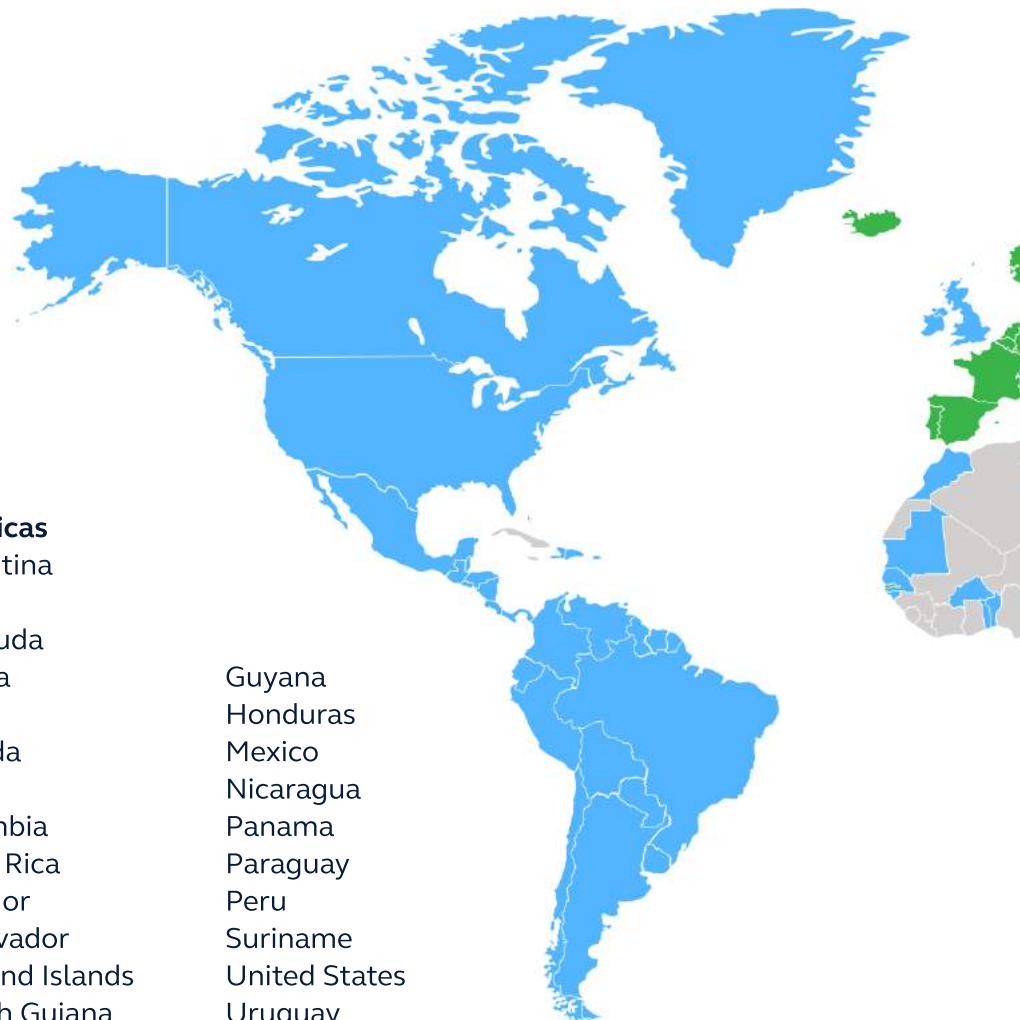

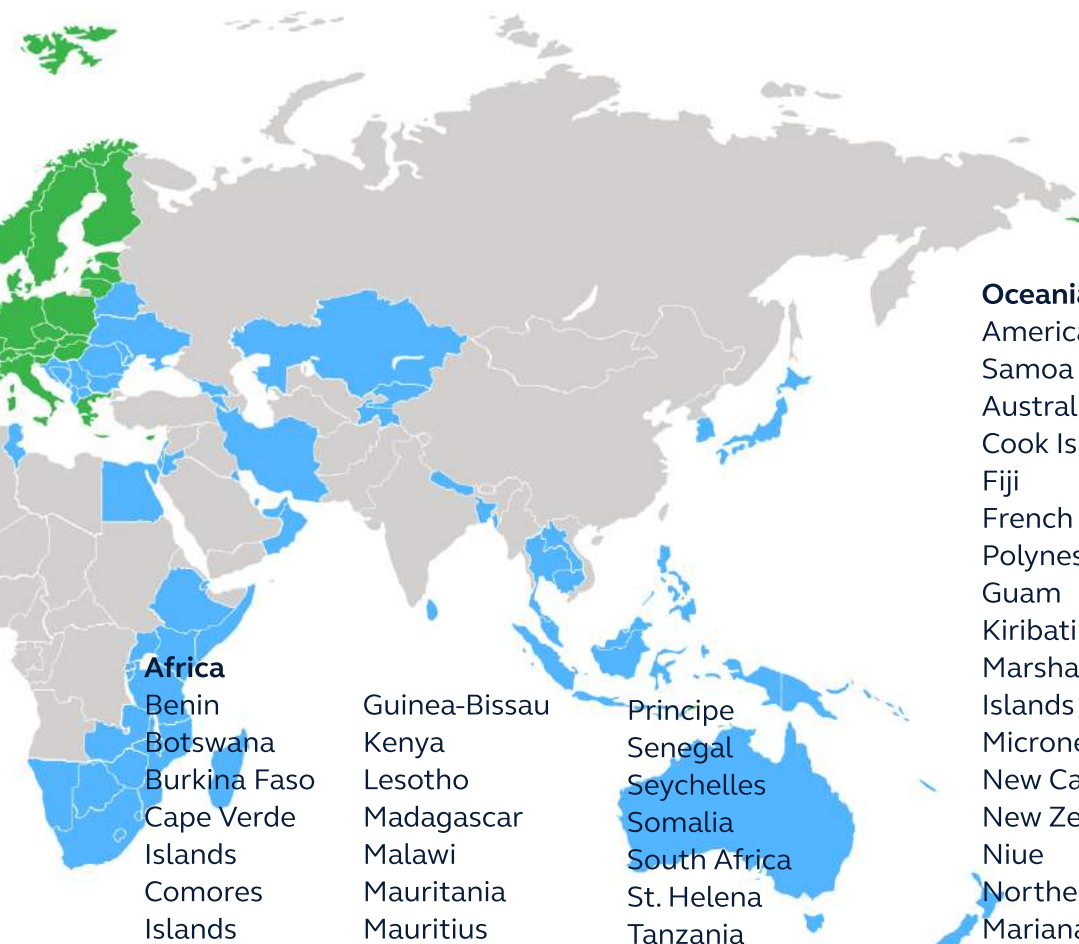

Eligibility Criteria

Applicants under the Program must meet the following requirements:

- | Be at least 18 years of age;
- | Have no previous criminal convictions;
- | Be ready to spend at least 7 days per year in Portugal;
- | Proof of the qualifying investment.

The path to Portuguese citizenship

Portugal now considers the waiting time during residency application processing when calculating the required legal residency period for nationality. The five year clock starts ticking from the point of application, not from the issuance date of the initial residency permit. This change brings relief to applicants affected by delays in processing.



Portugal Golden Visa Application Process

We have created a streamlined process and your dedicated team will assist you through every stage of your residency application.

- 1 Initial Consultation**

- 2 Prepare Documents**

Official documentation is central and critical to the entire process and all required documents, required for your application, must be properly collected. We'll provide you with a checklist so you know what and how to collect them and how to send them to us. Your dedicated team will prepare the documentation along with the application - ensuring everything is done correctly, securely, and all information is accurate. We advise not to begin collecting documents until our experts instruct you to.
- 3 Complete The Investment**

Transfer the investment funds to the bank account in Portugal.
- 4 Submit Residency Application**

The complete application along with all supporting documents will be submitted to the competent immigration authority, the body that processes Golden Residence Permit applications along with documentary evidence of the investment.
- 5 Book A Biometrics Appointment**

We will book an appointment for you and your family to submit biometrics in Portugal.

Receive Residence Permit

Once the application is reviewed you will be granted the residence permit, valid for 2 years, extendable for 2 years each time, provided you meet the 7 days per year requirement (2nd year onwards is 14 days a year), with the right to settle in Portugal and travel throughout the Schengen area.
